It is the duty of the sales representative to seek such approval before deducting the amount from your payment.

The undersigned purchaser agrees to pay, in the event the account becomes delinquent, fees equal to 33 1/3% of the balance due plus all attendant collection costs.

The undersigned purchaser agrees that the state of West Virginia shall control this contract and the courts of Kanawha County, West Virginia, shall have jurisdiction if any legal action is undertaken to collect any delinquent account.

I hereby grant to BUZZ PRODUCTS, INC. the permission to check my references with individual or business and to make available in the future my experience with other business for the purpose of securing credit.

If I do not pay the entire balance according to the terms, a finance charge of 1 1/2 percent per month may be assessed against the balance until the balance for merchandise, services and accrued finance charges are paid in full (18% per annum).
